AFFIDAVIT FOR HOMEOWNER PLUMBING PERMIT

In making this application to install plumbing in the above residence, I agree that the work will be done promptly by myself or my agent in accordance with all requirements of the applicable code, and that I will be responsible for any and all suits or damages brought against the City of Farmington due to neglect or carelessness on my part.

Some provisions are:

1. That a permit must be secured before any work is started;
2. That plans for the work may be required;
3. That no work will be covered before inspection is made and approval received.

It is further agreed that the work is the sole responsibility of myself, and if upon inspection, the plumbing inspector finds that the work is substandard, he may require me to engage a licensed plumbing contractor at once to correct and finish the work.
