WEEKLY RECAP

May 29, 2017 thru June 4, 2017

Soliciting Complaint

On May 30th and June 2nd Officers responded to reports subjects going door to door attempting to sell magazine subscriptions in the areas of Whittaker/Oakland and Birchwood and Tall Oaks. In both instances the subjects were located and found to be in violation of the city ordinance to obtain and carry permits, the Officers issued citations and released the subjects.

Disorderly Conduct

On May 30th Officers responded to the area of Whittaker and Arundel for a report of an intoxicated female subject causing a disturbance. The complainant reported that the subject was bothersome, yelled profanities and exposed herself before departing. The subject was located a short distance away sleeping at her mother's residence. The 22 year old subject submitted to a PBT which resulted .30(1) and was issued a citation before being released to her mother.

Retail Fraud

On May 31st a Detective received additional information related to a retail fraud that occurred on April 25th at a Farmington business. On April 27th the suspects responsible for the theft were arrested and suspected stolen property recovered as a result of a traffic stop. At the time however, it was not certain where the suspected stolen property had been taken. As a result of the traffic stop and recovered property, the Farmington Detective and Loss Prevention officer were able to establish a timeline of the events and charges are pending at the Oakland County Prosecutors Office.

Possession of Marijuana

On June 1st a Sergeant stopped a vehicle on M5 near Farmington for failure to maintaining its lane, swerving and crossing the center line. After stopping the vehicle and speaking to the driver and passenger the Sergeant and assisting Officer suspected that the driver had provided a false name. The field investigation revealed the true identity of the driver and that they had a suspended license and warrants for their arrest and the passenger was in possession of marijuana. The driver and passenger were arrested and transported to jail.

Open Alcohol in a Motor Vehicle

On June 1st an Officer stopped a vehicle in the area of Farmington and Flanders after observing a broken tail light showing white light to rear. While talking to the driver the Officer detected the odor of an intoxicant and marijuana coming from the interior of the vehicle. The Officer discovered an open and half empty pint of Popov vodka near the driver's seat. The officer also determined that the driver's license was suspended and there was an active warrant for his arrest. The driver was arrest and transported to jail.

Possession of Marijuana

On June 2nd an Officer stopped a vehicle on Farmington near Eight Mile Road for having a defective driver side brake light. While talking with the driver, the Officer detected an odor of marijuana coming from the interior of the vehicle and learned that the driver's license was suspended. The driver was arrested and marijuana was found inside the vehicle between the seat and center console. The driver was transported to jail.

Damage to Government Property

On June 4th Officers responded to Lilac Street to document damage to City property. The Officer reported that unknown subjects vandalized a newly poured section of sidewalk by drawing designs, creating bicycle tracks and writing names in the wet concrete. The report will be forwarded to the school liaison officer for follow up.
