DISORDERLY PERSON (11-4034)

On August 1st, at 9:22 a.m., an officer took a report of a disorderly person at an apartment complex. Management at the complex stated they were having continual problems with a resident. The resident tried to spit on an employee and displayed disruptive behavior over the weekend although these incidents were never reported to this department. The resident who is well known by this department is suffering from mental health issues. An officer spoke to the residence's mother who then went to Pontiac and petitioned the court for her son to be evaluated. The mother returned with the proper court paperwork and the subject was taken to Botsford Hospital for evaluation.

DOG BITE (11-4047)

On August 1st, a 16 year old female reported at the front desk that she was bitten by a dog on Orchard Street, near Grove. The victim could only describe the dog as small, tan, and about 20 pounds. The victim had her injuries treated at Botsford Hospital. The dog could not be located.

OPERATE WHILE INTOXICATED Under 21/MINOR IN POSSESSION OF ALCOHOL (11-4049)

On August 2nd, at 01:15 a.m., officers stopped a vehicle for defective equipment. During the traffic stop it was learned all four occupants were under 21 and had been drinking. The three passengers were all issued citations for Minor in Possession of Alcohol by Consumption. The driver was arrested for Operating a Motor Vehicle Under 21 with Any Bodily Alcohol Content. Driver had a BAC of .07.

OPERATING WHILE INTOXICATED (11-4080)

On August 4th, at 2:00 a.m., officers stopped a vehicle for making an improper turn. The driver was found to be intoxicated and arrested for Operating While Intoxicated (BAC .12).

LARCENY IN A BUILDING (11-4089)

On August 4th, at 2:32 p.m., an officer responded to T.J. Maxx for a stolen wallet report. The reporting party stated that while she was shopping someone took her wallet out of her purse. The reporting party reports leaving her purse unattended for a minute. Security video footage was reviewed but was unsuccessful in identifying a suspect.

OPERATING WHILE INTOXICATED (11-4122)

On August 5th, at 1:05 a.m., officers stopped a vehicle for a defective equipment violation. The driver was found to be intoxicated and arrested. Subject became uncooperative and refused a breathalyzer. A search warrant for blood was obtained. Subject had a prior drunk driving conviction from 2003.

MALICIOUS MISCHIEF (11-4139)

On August 7th, at approximately 8:20 a.m., an officer took a report of malicious mischief on Heatherton. Unknown individuals poured mustard and chocolate syrup on a vehicle sometime over night. There was no damage to the vehicle.

TRESPASSING (11-4149)

On August 7th, officers responded to Flanders Elementary School, which is currently being demolished, for a report of several juveniles climbing over the fences and into the old building. Upon arrival officers located the three juveniles walking through the school parking lot. The juveniles admitted to having gone into the sectioned off area despite the no trespassing signs. The juveniles were in the area from Rochester Hills in order to attend a graduation party in the Meadows Subdivision. The juveniles were turned over to their parents with a warning.
