### **DISORDERLY PERSON ARREST (11-5669)**

On October 31<sup>st</sup>, an officer was dispatched to Country Apartments (33250 Freedom) regarding an intoxicated male trying to gain entry into a building. Upon arrival, the officer made contact with the male subject who was visibly intoxicated. A subsequent PBT revealed an alcohol level of .26(3). The subject produced identification out of Illinois but could not recall where he resided locally. The subject had been pounding on the door for fifteen minutes and randomly buzzing apartment units at 2:00 a.m. The subject was arrested for disorderly/intoxicated person. The subject was processed and housed until sober. The officer issued the subject a citation for Disorderly/Intoxicated Person.

### **ODOR INVESTIGATION (11-5673)**

On October 31<sup>st</sup>, officers responded to Farmington Place Apartments on a smoke investigation. Upon arrival officers found light smoke in an apartment. It was learned the resident left a pan on the stove which began smoking.

### **LARCENY IN A BUILDING (11-5682)**

On October 31<sup>st</sup>, a resident of the Chatham Hill's Apartments reported that between July of 2011 and October of 2011 an unknown person had stolen two DVD players, a remote control car and several items of clothing out of his storage unit at the complex. The resident does not know who stole the items or when they were stolen.

### **FRIEND OF THE COURT WARRANT ARREST (11-5691)**

On November 1<sup>st</sup>, an officer observed a vehicle with an expired registration plate eastbound Ten Mile at Orchard Lake Road. A traffic stop was conducted and the driver identified. The driver had a valid license with an outstanding Friend Of the Court (FOC) warrant out of Macomb County. Macomb County confirmed the warrant as valid and wished to pick up the subject. The driver was arrested on the warrant and housed at this department.

### **LARCENY FROM VEHICLE (11-5697)**

On November 1<sup>st</sup>, residents at Valley View Condominiums reported five vehicles were broken into during the night. The officer who responded found property and

other physical evidence at the scene. There was no damage to the vehicles that were broken into.

**LARCENY FROM AUTO (11-5725)**

On November 2<sup>nd</sup>, a resident of Farmington reported that her purse was stolen from her unlocked vehicle while she was at Kil's Taekwondo (32326 Grand River). The resident stated her purse was on the driver's seat of the vehicle at the time it was taken. No suspects or suspicious persons seen in the area.

**SUSPICIOUS PERSONS (11-5739)**

On November 4<sup>th</sup>, as a result of an e-mail Crime Alert to residents, officers responded to suspicious persons at Jamestown Apartments. Officers located two subjects near the complex on bikes. Field investigation and evidence indicated these two subjects were possibly involved in recent larcenies (see 11-5697). The subjects were arrested for an outstanding warrant and minor consuming alcohol. Both were transported to this station and turned over to detectives for interviews and follow up. Detectives are conducting follow-up investigation on their possible involvement on the recent larcenies.

**DOMESTIC ASSAULT (11-5741)**

On November 4<sup>th</sup>, a resident of Belaire Subdivision reported two people (male and female) fighting in the front yard. The male then fled the scene in a vehicle. The responding officer found it was a boyfriend and girlfriend fighting over car keys. The two involved were staying at a family member's home where they were fighting in front of. A report was filed with the Oakland County prosecutor for possible charges.

**ROAD RAGE (11-5742)**

On November 4<sup>th</sup>, a driver and passenger came into station to report a road rage incident that had just occurred at the M-5 exit and Nine Mile. It was reported that the driver (male, 30's) of another vehicle became angry over the driver merging into traffic on I-96 in Wixom. The other driver caught up to them on M-5, cut them off and got in front of their vehicle as they exited. While stopped at Nine Mile, the man got out of his car and approached their vehicle. He threw a cigarette at their car and climbed on the hood and began banging on their windshield. The driver and passenger obtained his license plate and fled to this station. Officers are attempting to make contact with the male driver.

**OPERATE WHILE INTOXICATED/MINOR IN POSSESSION (11-5760)**

On November 6<sup>th</sup>, an officer stopped a vehicle for weaving within and out of its lane on Grand River near Orchard Lake. The driver admitted to drinking and was asked to perform field sobriety tests which she failed. The driver was arrested for Operating While Intoxicated and transported to the station. At the station, the driver submitted to breath testing which showed her BAC (blood alcohol content) to be .15. A passenger in the car who was twenty years old was also cited for

minor in possession of alcohol. She submitted to a PBT (Preliminary Breath Test) with a result of .04. She was transported home by officers.

**BREAKING AND ENTERING/MALICIOUS DESTRUCTION OF PROPERTY  
(11-5768)**

On November 6<sup>th</sup> (Sunday), a Farmington High School maintenance worker observed a young girl climbing into the school through a window that she had broken the screen out of. When he called out to her she climbed back out of the window, said she was sorry and ran away. The maintenance worker contacted the school athletic director who responded and determined a probable suspect. Officers made contact with the juvenile who admitted to the crime. The school stated that they would follow-up on the matter on Monday.
