WEEKLY RECAP

October 19 - October 25, 2015

ACCIDENTAL PROPERTY DAMAGE

On October 19th at approximately 7:54 AM an officer was dispatched to the area of Nine Mile and Farmington Rd for a report of a broken car window. Upon arrival the officer learned from the driver that he was driving on Nine Mile Rd when all of a sudden his back window shattered. The driver did not hear or see anything hit the glass. It is unknown what caused the damage.

POSSESSION OF MARIJUANA

On October 19th at approximately 2:47 PM an officer on patrol stopped a vehicle in the area of Grand River and Orchard Lake for having an expired license plate and a cracked windshield. A subsequent investigation revealed that the driver had never obtained a driver's license and had warrants for his arrest out of another police agency for being in possession of narcotic paraphernalia. The driver was arrested for driving without a license and an inventory search of his vehicle revealed a baggie of marijuana and an open bottle of liquor. The driver was housed at the Farmington Jail.

SUSPICIOUS PERSON

On October 19th at approximately 8:10 PM an officer was dispatched to a deli restaurant on the 33100 block of Grand River Ave for a report of a possible quick change scam artist. Upon arrival the officer learned from the cashier that the suspect had come into the deli and purchased \$3 worth of cheese. The man initially gave the cashier a \$20 bill and then advised that he had \$3 exact. The cashier gave the man his \$20 back and he advised her that she had only given him \$1. The cashier immediately recognized that the man was trying to scam her so she confronted him resulting in him leaving the business. The suspect is described as a heavy set 40-50 year old white male with a goatee and shoulder length hair driving a silver older model Cadillac.

NEVER ACQUIRED DRIVER'S LICENSE

On October 20th at approximately 8:13 AM an officer on patrol stopped a vehicle in the area of Shiawassee and Orchard Lake for speeding. A subsequent investigation revealed that the

driver had never obtained a driver's license. The driver was arrested for driving without a license and processed at the Farmington Jail. The driver was released with a citation.

MISDEMEANOR WARRANT OTHER POLICE AGENCY

On October 20th at approximately 10:50 PM an officer on patrol stopped a vehicle in the area of Nine Mile and Farmington Rd for a license plate violation. Further investigation revealed that the driver had two warrants for her arrest out of nearby police agencies. The driver was arrested on the warrants and was turned over to a neighboring police agency.

DROVE WHILE LICENSE SUSPENDED

On October 21st at approximately 9:08 AM an officer on patrol stopped a vehicle in the area of Farmington Rd and Nine Mile because the driver matched the description of the registered owner, who had a suspended driver's license. Further investigation verified that the driver had a suspended driver's license. The driver was arrested for driving on a suspended license and was processed at the Farmington Jail. The driver was released with a citation.

RECEIVE AND CONCEAL STOLEN PROPERTY

On October 21st a student reported to the School Liaison Officer that his cell phone was stolen out of an unlocked locker at the Farmington High School. A subsequent investigation revealed that the phone was located in the pocket of another student. The suspect was arrested for being in possession of stolen property and was referred to Oakland County Teen Court.

ILLEGAL USE OF CREDIT CARD

On October 21st a Longacre St resident came into the public safety department to report that an unknown person charged over \$400 worth of merchandise to her Hantz Bank Debit Card. The investigation was turned over to the Detective Bureau for further investigation.

OPERATE WHILE INTOXICATED 3RD OFFENSE

On October 22nd at approximately 1:31 AM an officer on patrol stopped a vehicle in the area of Orchard Lake and Grand River for speeding. Further investigation revealed that the driver exhibited signs of intoxication. The driver failed several sobriety exams and was arrested for operating while intoxicated. A check of the driver's criminal history showed that he had been previously convicted of OWI twice. The driver submitted to a Datamaster Breath Test with a result of a .21 BAC. The driver was housed at the Farmington Jail.

OPERATE WHILE INTOXICATED 2ND OFFENSE

On October 23rd at approximately 1:18 AM a sergeant on patrol stopped a vehicle in the area of Grand River and Whitaker for speeding and erratic driving. Further investigation revealed that the driver exhibited signs of intoxication. The driver failed several sobriety exams and was arrested for operating while intoxicated. The driver refused to take a Datamaster Breath Test so a search warrant was sought for his blood. The driver has a prior conviction for operating while intoxicated and was housed at the Farmington Jail.

On October 23rd at approximately 1:39 PM an officer on patrol stopped a vehicle in the area of Drake and Drakeshire for speeding. Further investigation revealed that the driver had a suspended license and a warrant for his arrest out of a nearby police agency. The driver was arrested for driving on the suspended license and housed at the Farmington Jail.

CIVIL MATTER

On October 24th at approximately 10:49 AM an officer was dispatched to a report of a civil complaint at a business on the 31700 block of Grand River. Upon arrival the officer learned from the business owner that her landlord had contracted with a roofing company to replace the roof to the business. When the business owner opened her store in the morning, she discovered that the roof had leaked, causing water damage to all of her merchandise. The business owner wanted the incident documented.

DROVE WHILE LICENSE SUSPENDED

On October 24th at approximately 2:17 PM an officer on patrol stopped a vehicle in the area of Ten Mile and Orchard Lake for a defective equipment violation. Further investigation revealed that the driver had a suspended license. The driver was arrested for driving on the suspended license and was processed at the Farmington Jail. The driver was released with a citation.

VEHICLE TAKEN WITHOUT PERMISSION

On October 24th a Southfield resident reported at this public safety department that his vehicle was taken without permission at a gas station at Grand River and Drake on October 23rd. The vehicle owner advised that he had driven to the gas station with his girlfriend and that when he went inside the business his girlfriend drove away with his vehicle. The vehicle owner attempted to retrieve his vehicle from his girlfriend, but could not locate her or his vehicle. With the assistance of the Detroit Police Department, the vehicle was located in the City of Detroit. The owner did not want to press charges.

MISDEMEANOR WARRANTS OTHER POLICE AGENCY

On October 24th a LEIN check of the above vehicle owner revealed that he had a warrant out of the City of Farmington Hills. The man was arrested on the warrant and turned over to the Farmington Hills Police Department.

SUSPICIOUS CIRCUMSTANCE

On October 24th at approximately 8:40 PM officers were dispatched to a residence on Brittany Hill St. for a report of a suspicious circumstance. Upon arrival the officers learned from the complainant that the home is owned by her father who lives in a nursing home. On this date the father received a phone call from a neighbor who was concerned about a pair of men in a blue van who were seen walking around the home. The father asked the complainant to check the home and when she arrived she found the back door unlocked. Officers and the daughter checked the home and noted nothing missing or disturbed.

DROVE WHILE LICENSE SUSPENDED

On October 24th at approximately 10:54 PM an officer on patrol stopped a vehicle in the area of Grand River and Orchard Lake for disobeying the no turn on red sign. Subsequent
