Agenda Topic: Review and Consider Final Draft of Request for Qualifications for Maxfield Training Center (MTC)		
<u>Proposed Motion</u> : Move to accept RFQ and have city administration publish it to receive potential interest.		
Background: At its September 2 Special Council Meeting, City Council was presented with the RFQ for the Maxfield Training Center. Carmine Avantini and Justin Sprague of Community Image Builders (CIB), along with Eric		
Helzer of Advanced Redevelopment Solutions (ARS) were hired by the city for services in connection with redevelopment of the Maxfield Training Center. They presented the RFQ to council at the Sept. 2 meeting. After reviewing, Council asked for certain changes to the RFQ. The consultants are here to present the updated draft.		
Mr. Avantini has special experience with similar redevelopment projects. Mr. Helzer brings additional specialty of financing redevelopment projects and creating informational documents for development projects (e.g., request for proposals), has partnered with CIB on the MTC project.
